RESOLUTION REQUESTING FUND ASSISTANCE FROM THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) SECRETARY MARK A. VILLAR, THROUGH DISTRICT ENGINEER NONIE A. VIYAR OF ILOILO 1ST ENGINEERING DISTRICT, FOR THE CONSTRUCTION OF SLOPE RIVER PROTECTION LOCATED AT BARANGAY NAPNAPAN SUR, TIGBAUAN, ILOILO.

WHEREAS, the Municipality of Tigbauan is a component town of the Province of Iloilo with 52 barangays, having a population of 62,706 inhabitants as of 2016;

WHEREAS, the hanging foot bridge of Barangay Napnapan Sur, in the Municipality of Tigbauan was constructed some decades ago;

WHEREAS, said hanging foot bridge had been repaired last year 2018 through the assistance of the Governor Arthur Defensor, Sr. of the Province of Iloilo;

WHEREAS, one critical problem of Barangay Napnapan Sur, is the continuous erosion of the riverbanks where this foot bridge is situated due to the strong impact of water current during rainy season;

WHEREAS, this river slope protection is very beneficial for the eleven (11) barangays of the municipality namely: Barosong, Bayuco, Bitas, Canabuan, Cordova Norte, Cordova Sur, Isian, Nagba, Napnapan Norte, Napnapan Sur and San Rafael;

WHEREAS, due to budgetary constraints, the Municipality of Tigbauan is requesting financial assistance from your good office for the construction of river slope protection along Barangay Napnapan Sur, this Municipality;
