RESOLUTION FORGING A SISTER-CITY RELATIONSHIP AND TWINNING AGREEMENT WITH ZAMBOANGA CITY TO FOSTER AND PROMOTE EXCHANGES IN VARIOUS FIELDS OF ENDEAVORS

WHEREAS, Article III, Section 33 of the Local Government Code of 1991 partly provides that *“Local government units may, through appropriate ordinances, group themselves, consolidate, or coordinate their efforts, services, and resources for purposes commonly beneficial to them”*;

WHEREAS, the sister city relations brings together LGUs into a closer relationship where cooperation, cultural and economic understanding are realized for the citizenry's mutual benefit;

WHEREAS, this “PEOPLE TO PEOPLE PROGRAM” is aimed at establishing greater friendship and understanding between people of varied but similar adherence to political, socio-cultural, agricultural and economic programs through the medium of direct inter-personal contact;

WHEREAS, technical exchanges and cooperation program among Local Government Units (LGU) through sisterhood and twinning relationship uphold to promote mutual understanding and goodwill on the multifarious dimensions of local government thereby assuring its inhabitants peace, stability and prosperity, today and beyond;
