**Resolution No. 2019-101**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPALITIES IN THE FIRST DISTRICT OF ILOILO FOR THE IMPLEMENTATION OF 2019 INTERTOWN SPORTS TOURNAMENT

WHEREAS, every September of the year is celebrated as the Civil Service Month in commemoration of the enactment of Public Law No. 5, *“An Act for the Establishment of an Efficient and Honest Civil Service in the Philippine Islands”* on September 19, 1900 and this year is the 119<sup>th</sup> Anniversary of the Philippine Civil service with the theme *“Civil Service at 119: Upholding Integrity and Building a High Trust Society”*;

WHEREAS, Section 28 (a) of Republic Act No. 2260, otherwise known as the Civil Service Act of 1959 and Section 29 of Presidential Decree No. 807, known as the Civil Service Decree of the Philippines mandate every agency to take necessary steps toward the creation of an atmosphere conducive to good employee relationships, improvement of employee morale and provisions for employees’ health, welfare, counseling, recreation, and similar services;

WHEREAS, the municipalities in the First District of Iloilo organized an Intertown Sports Tournament, a sports competition to be participated by municipal officials and employees in order to provide an outlet for civil servants to loosen up and recharge, promote friendships, and build relationships and connections with other municipal employees in the district;

WHEREAS, this Inter-town Sports Tournament shall include the Municipalities of Oton, Tigbauan, Guimbal, Igaras and Miag-ao;

WHEREAS, it was agreed during meetings that the Municipality of Tigbauan shall have the responsibility to accept contributions in the amount of TWENTY THOUSAND PESOS (Php20,000.00) from the other municipalities to defray the expenses for the above-said undertaking;

WHEREAS, the Municipality of Tigbauan, is requesting for the release of TWENTY THOUSAND PESOS (Php20,000.00) from each municipality;

WHEREAS, the amount of TWENTY THOUSAND PESOS (Php20,000.00) shall be transferred to the Municipality of Tigbauan to be used solely for the 2019 Inter-town Sports Tournament;

WHEREAS, in view of the abovementioned premises, the Municipality of Tigbauan and the Municipalities of Oton, Guimbal, Igaras and Miag-ao hereby agree to the following:

1. *The Municipality of Tigbauan will monitor and evaluate the implementation of the funds transferred;*
2. *The Municipality of Tigbauan shall take full responsibility in the proper disposition/disbursement of funds in accordance with the implementing guidelines and rules and regulations of the Commission on Audit (COA);*
3. *The Municipality of Tigbauan shall use the funds of the Municipal Governments of Oton, Guimbal, Igaras and Miag-ao solely for the implementation of the specific activity/event;*
4. *The Municipality of Tigbauan, after each assistance, the Accountable Officer shall prepare and submit to the Municipal Governments of Oton, Guimbal, Igaras and Miag-ao the Statement of Expenditures duly signed by the Municipal Mayor and verified by the Commission on Audit (COA);*
5. *The Municipality of Tigbauan will return any unexpended balance of funds released and refund any disallowance made by the municipal auditor in the course of post audit transaction;*


NOW, THEREFORE, on motion of Hon. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, Committee on Education, Tourism and Civil Service* and duly seconded by Hon. Dennis T. Valencia, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan to enter into a Memorandum of Agreement (MOA) with the Municipalities in the First District of Iloilo for the implementation of 2019 Inter-town Sports Tournament,
