**Resolution No. 2019-108**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH BARANGAY **TARO**, TIGBAUAN, ILOILO FOR THE TRANSFER OF FUNDS AS FINANCIAL ASSISTANCE IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P200,000.00) FOR THE PURCHASE OF RESPONDER VEHICLE.

**WHEREAS**, under the Local Government Code, Local Government Units are mandated to address the needs of its constituencies, and empower the people through direct participation in the affairs of government, by allowing them the widest possible apace to decide on, initiate, implement, and innovate on development activities that address their identified needs;

**WHEREAS**, as convergence strategy, the Municipal Government of Tigbauan recognizes and appreciates the efforts and participation of the Barangay Councils in responding to the needs of its constituents;

**WHEREAS**, the LGU-Tigbauan has appropriated the amount of *Two Hundred Thousand Pesos (P200,000.00) as Financial Assistance for the Procurement of Responder Vehicle* as identified in the 2019 Supplemental Budget – Assistance to Barangay Disaster Risk Reduction and Management Council;

**WHEREAS**, Barangay Taro requested for the release of the above-mentioned amount to implement the project;

**WHEREAS**, the amount of TWO HUNDRED THOUSAND PESOS (P200,000.00) shall be transferred to Barangay Taro for them to implement the said project;

**WHEREAS**, premises considered, the LGU-Tigbauan and Barangay Taro hereby agree to the following:

1. LGU-Tigbauan will monitor and evaluate the project in coordination with the Municipal Engineering Office;
2. Barangay Taro shall take full responsibility in the proper disposition/disbursement of funds in the implementation in accordance with the implementing Guidelines and COA rules and regulations;
3. Barangay Taro shall use the funds of the Tigbauan Municipal Government solely for the implementation of the specific project;
4. Barangay Taro, after each assistance, the Accountable Officer shall prepare and submit to the Tigbauan Municipal Government the Statement of Expenditures duly signed by the Barangay Treasurer and verified by COA.
5. Barangay Taro will complete the project within 120 calendar days (inclusive of 45 days procurement activity)
6. Barangay Taro will return any unexpended balance of funds released and refund any disallowance made by the Municipal Auditor in the course of post audit transaction.


NOW, THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, Committee on Appropriations, Budget, Finance and Accounts* and duly seconded by Hon. Neri T. Camiña, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba and Hon. Jerry T. Tuares;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette T. Alquisada, for and in behalf of the Municipality of Tigbauan to Enter Into A Memorandum of Agreement with Barangay Taro, Tigbauan, Iloilo for the transfer of funds as financial assistance in the amount of Two Hundred Thousand Pesos (P200,000.00) for the purchase of Responder Vehicle,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor, Suzette Tenefrancia-Alquisada, to Barangay Taro and to all concerned for their information and appropriate action.
