RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONORABLE WILLIAM DAR, SECRETARY OF THE DEPARTMENT OF AGRICULTURE IN THE AMOUNT OF FIFTY MILLION PESOS (P50,000,000.00) FOR THE CONCRETING OF NAPNAPAN-LINO FLORES FARM-TO-MARKET ROAD IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO, PHILIPPINES.

WHEREAS, the Municipality of Tigbauan is a second class municipality located in the First Congressional District, southernmost part of the Province of Iloilo with a population of 63,986 more or less based on the unofficial 2011 Population Consolidation Report by the Provincial Population Office;

WHEREAS, Tigbauan is composed of 52 Barangays and with a total land area of 8,889 hectares, 93.78% of which is devoted to agriculture and allied activities which serve as one of the main sources of livelihood of the population;

WHEREAS, the construction or improvement of farm to market roads will ensure a convenient, fast and safe transport of farm products to the trade and economic center of the town thereby increasing the chances for economic growth and sustainable development;

WHEREAS, due to financial constraints, the municipal officials cannot afford to undermine the necessity of the immediate maintenance, repair and construction of our farm to market roads, thus, this request for financial assistance from the Department of Agriculture is a must;

WHEREAS, the people of Tigbauan and its officials and employees are one with the vision of the current administration to lead the Filipinos into the road towards a corruption-free, honest, transparent and dedicated governance characterized by tangible and responsive programs for progress and development that is felt up to the grassroots of society;
