**Resolution No. 2019-113**

RESOLUTION ADOPTING THE TEN-YEAR SOLID WASTE MANAGEMENT PLAN 2017-2026 OF THE MUNICIPALITY OF TIGBAUAN, ILOILO.

WHEREAS, on September 26, 2019, Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor, this municipality urgently requested the Sangguniang Bayan for the passage of a "Resolution Adopting the Ten-Year Solid Waste Management Plan (2017-2026) of the Municipality of Tigbauan";

WHEREAS, the Municipality of Tigbauan had adopted the *Ten-Year Solid Waste Management Plan 2015-2024* last September 28, 2016. However, this was recommended by the National Solid Waste Management Commission as implementable but has to supplement the plan specifically for the total closure of the open controlled dumpsite and the data required;

WHEREAS, Environmental Management Bureau-Department of Environment and Natural Resources (EMB-DENR 6) suggested to use the new template for the final deliberation and further recommended for updating the plan to 2017-2026;

WHEREAS, it is necessary that the said plan should be approved first at the municipal level by the local legislative body and the Local Chief Executive for adoption prior approval of the National Environmental Management Commission;

NOW THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment & Expropriation* and was duly seconded by Hon.
