RESOLUTION CONFORMING AND APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2019-06, DATED OCTOBER 3, 2019, *“RESOLUTION APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) 20% INTERNAL REVENUE ALLOTMENT (IRA) FUND, GENERAL EXPENDITURES (5% MDRRM FUND, SEF AND OTHER SOURCES) FOR CY 2019 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.”*

WHEREAS, the Local Chief Executive in a letter dated October 7, 2019, requested this Sangguniang Bayan for the urgent passing of a resolution approving and conforming Municipal Development Council (MDC) Resolution No. 2019-06, dated October 3, 2019, *“Resolution Approving the Supplemental Annual Investment Program (AIP) 20% Internal Revenue Allotment (IRA) Fund, General Expenditures (5% MDRRM Fund, SEF and Other Sources) for CY 2019 of the Municipality of Tigbauan, Province of Iloilo;*

WHEREAS, the Municipal Development Council’s participation is necessary for the approval of the aforementioned CY 2019 Supplemental Annual Investment Program (AIP) of the Municipality of Tigbauan, Province Of Iloilo;

WHEREAS, during its participative workshop with the involvement of various stakeholders from different sectors (*namely: Administrative Services Sector, Social Development Sector, Economic Development Sector, Environmental Management Sector and Physical/Land Use/Infrastructure Development Sector*), the Municipal Development Council thoroughly identified, analyzed and prioritized various programs, projects and activities of this municipality for CY 2019;

WHEREAS, the output of the various stakeholders from the said sectors were concretized into the Supplemental Annual Investment Program to which the good Mayor, Atty. Suzette T. Alquisada, had discussed and presented;

WHEREAS, the General Expenditures was also thoroughly discussed and explained to the body as to various budget allocations stated for each department of the local government unit and the necessary services for the general welfare of the citizenry of Tigbauan;

WHEREAS, the Supplemental Annual Investment Program (AIP) for CY 2019 with the total amount of **Twenty-Nine Million Two Hundred Forty Thousand Pesos (P29,240,000.00)** is allocated for identified specific PPAs;
