WHEREAS, as provided for by Republic Act No. 6975, Sec. 43, the Sangguniang Panglunsod/Bayan in every city and municipality shall create such number of People's Law Enforcement Board (PLEB). The PLEB shall have jurisdiction to hear and decide citizens' complaints or cases filed before it against erring officers and members of the PNP;

RESOLVED, to reorganize The People's Law Enforcement Board (PLEB) In The Municipality Of Tigbauan, Province Of Iloilo,


