RESOLUTION TO SUPPORT THE PROJECT: *CONSTRUCTION OF MULTI-PURPOSE BUILDING INCLUDING PAVEMENT*, AT BAGACAY NATIONAL HIGH SCHOOL, TIGBAUAN, ILOILO IN THE AMOUNT OF FOUR MILLION PESOS (P4,000,000.00).

WHEREAS, in a letter dated October 9, 2019, the Hon. Mayor, Atty. Suzette Tenefrancia-Alquisada, requested this August Body for the urgent passing of a “*Resolution relative to the Construction of Multi-Purpose Building including pavement, at Bagacay National High School, Tigbauan, Iloilo in the amount of Four Million Pesos (P4,000,000.00);*”

WHEREAS, Tigbauan is a 2<sup>nd</sup> Class Municipality, generally having a flat terrain, coastal town situated 23 km. Southwest of Iloilo City and the main sources of income of the people are fishing and farming;
