**Resolution No. 2019-122**

RESOLUTION ADOPTING PROVINCIAL ORDINANCE NO. 2017-152, OTHERWISE KNOWN AS THE TRAFFIC CODE OF THE PROVINCE OF ILOILO, FOR A UNIFIED TRAFFIC ORDINANCE AND EFFECTIVE ENFORCEMENT OF THE TRAFFIC RULES AND REGULATIONS IN THE PROVINCE OF ILOILO

WHEREAS S.P. Resolution No. 2019-345, entitled: *Resolution Requesting The Mayors And The Sanggunians Of The Forty Two (42) Municipalities And One (1) Component City In The Province Of Iloilo To Adopt, By Way Of Resolution, Provincial Ordinance No. 2017-152, Otherwise Known As The Traffic Code Of The Province Of Iloilo, For A Unified Traffic Ordinance And Effective Enforcement Of The Traffic Rules And Regulations In The Province Of Iloilo* was referred to the S.B. Committee On Transportation during SB's 39th Regular Session dated September 25, 2019;

WHEREAS, the 12th Sangguniang Panlalawigan of Iloilo enacted Provincial Ordinance No. 2017-152, *An Ordinance Enacting The Traffic Code Of The Province Of Iloilo, Amending Provincial Ordinance No. 2016-129, Subject To All Laws And Existing Legal Rules And Regulations;*

WHEREAS, based on the peace and order situation report of the Iloilo Provincial Police Office last July 30, 2019, traffic accidents, as a whole, is a major contributory factor to the increase of non-index crime rated at 70%, thereby necessitating the need to adopt the abovementioned Ordinance by the component LGUs for a unified Traffic Ordinance and effective enforcement of traffic rules and regulations in the Province of Iloilo;

NOW, THEREFORE, on motion of HON. MARLON R. TERUÑEZ, *Chairman, Committee on Transportation* and duly seconded by Hon. Dennis T. Valencia, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED AS IT IS HEREBY RESOLVED, to adopt Provincial Ordinance No. 2017-152, otherwise known as The Traffic Code of the Province of Iloilo, for a unified traffic ordinance and effective enforcement of the traffic rules and regulations in the Province of Iloilo,
