RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT WESTERN VISAYAS, FOR THE PROVISION OF MOBILIZATION OF FUNDS IN SUPPORT TO THE IMPLEMENTATION OF THE MEASLES-RUBELLA SUPPLEMENTAL IMMUNIZATION ACTIVITY (MR-SIA) 2019 IN THE MUNICIPALITY OF TIGBAUAN

WHEREAS, in February 7, 2019, DOH Sec. Francisco Duque III declared Measles Outbreak in 5 regions of the Philippines – NCR, CALABARZON, Central Luzon, Central Visayas, and Western Visayas. To avert the ongoing transmission, DOH issued Department Memorandum 2019 – 0048: “Conduct of Mixed Method: Non-selective and Selective Mass Measles and Polio Vaccination for Targeted Population.”

WHEREAS, in 2019, the Department of Health CHD WV through its Department Advisory No. 1 s. 2019: “Action Points to Interrupt Transmission of Measles Virus in Western Visayas” identifies the priority strategies to stop measles virus transmission and this include the conduct of the Region-wide Measles-Rubella Supplemental Immunization Activity in 2019.

WHEREAS, Western Visayas was able to vaccinate 685,062 children or 95% of the targeted less than 5 years old children as of June 30, 2019. Other targeted age groups included catch-up vaccinations for unvaccinated Grade 1 and Grade 7 students in public schools as well as frontline health workers in the hospitals and rural/district health units.

WHEREAS, as per DOH CHD WV Order No. 2019-25 or the Regional Guidelines on the Provision of Mobilization Funds in Support to the Implementation of the Measles-Rubella Supplemental Immunization Activity (MR SIA) 2019 in Western Visayas, the DOH CHD WV shall transfer funds amounting to Five Million Pesos (P5,000,000.00) to these LGUs (Annex A of DOH CHD WV Order No. 2019-25) following the mobilization payment scheme stipulated in the department order. The referred scheme is hereto attached as Annex C and shall be made an integral part of this Agreement;

WHEREAS, for and in consideration of the foregoing premises the DOH CHD WV hereby allocates the maximum amount of **SIXTY THOUSAND TWO HUNDRED THIRTY TWO and FIFTY CENTAVOS (P60,232.50)** Mobilization Fund to the Municipality of Tigbauan under MR SIA 2019 Mobilization Scheme (Annex C) of DOH CHD WV Order No. 2019-25 chargeable against the SAA 2019-07-0899 funds for the implementation of the MR SIA 2019, subject to the following agreement as follows:

RESPONSIBILITIES of the DOH CHD WV:

1. *The Department of Health Center for Health Development Western Visayas shall transfer the funds to the Municipality of Tigbauan, based on the accomplishment of the LGU as provided in Annex C Payment Scheme of DOH CHD WV Order No. 2019-25.*
2. *Regional NIP Program Managers and other FHN cluster members shall conduct pre-implementation and implementation monitoring to the priority areas.*
3. *DOH CHD WV shall conduct monitoring to ensure thoroughness and completeness of the implementation of the MRSIA 2019.*
4. *DOH CHD WV shall review the MR SIA 2019 Accomplishment.*
5. *DOH CHD WV shall monitor the compliance of the LGU to the agreed MR SIA 2019 implementation guidelines and immediate utilization of the funds.*

RESPONSIBILITIES of the LGU:

1. *Shall submit the List of Vaccination team members duly signed by the Head of Office*
2. *Shall submit to the DOH CHD WV the MR SIA 2019 Accomplishment Report duly signed by the Municipal Health Officer.*
3. *Shall provide the mobilization funds among vaccination teams as follows:*
 - a. *75% for Vaccinators (not to exceed P5,000.00 per vaccinator)*
 - b. *20% for Recorders / Guides (not to exceed P3,000.00 per recorder/guide)*
 - c. *5% for Supervisors (not to exceed P4,000.00 per supervisor)*
4. *Shall submit the Fund Utilization Report together with the signed payroll on or before December 15, 2019.*
5. *Shall submit a duly approved Work and Financial Plan for funds unutilized and reprogrammed for NIP activities.*
6. *Shall submit the Report of Checks Issued (RCI), Report of Disbursement (RD) to report utilization of funds reflecting the actual expenses incurred duly approved by the Local Chief Executive. Any unused balance upon completion of the project shall be returned to DOH CHD WV, pursuant to item 4.6 and 4.9 of COA Circular No. 94-013 dated December 13, 1994.*
