RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) REGIONAL OFFICE NO. 6 FOR THE IMPLEMENTATION OF THE NATIONAL PROGRAM "TARGETED ACTION TO REDUCE POVERTY AND GENERATE ECONOMIC TRANSFORMATION IN THE FISHERIES SECTOR (TARGET)" IN THE MUNICIPALITY OF TIGBAUAN."

WHEREAS, the Philippine Constitution directs the State to protect the rights of the subsistence fishermen, especially local communities, to the preferential use of communal marine and fishing resources, both inland and offshore and to provide support thereto through appropriate technology and research, adequate financial, production and marketing assistance and other services;

WHEREAS, BFAR is the Government agency responsible for the development, improvement, management and conservation of the country's fisheries and aquatic resources;

WHEREAS, BFAR implements the National Fisheries Program (NFP) which is designed to provide national directions and framework to develop and manage the country's fisheries resources for food security and ensures socio-economic upliftment of subsistence for fisherfolk;

WHEREAS, NFP encompasses all fisheries projects implemented by BFAR to include the national program "Targeted Action to Reduce Poverty and Generate Economic Transformation in the Fisheries Sector or TARGET" – an umbrella program of the Bureau to realize the goal on poverty reduction and inclusive economic growth in the fisherfolk communities;

WHEREAS, the Local Government Unit has the mandate to provide its constituents extension facilities related to agriculture and fishery activities which include water and soil resource utilization and conservation projects and enforcement of fishery laws in municipal waters;

WHEREAS, for Calendar Year 2019, the Municipality of Tigbauan is recipient of fisheries projects, Provision of Fish Gill Nets and Post-Harvest Kits;

WHEREAS, the parties concerned have willingly and jointly pledge to extend support and cooperation for the effective implementation, operation and good governance of the above-mentioned projects;

WHEREFORE, for and in consideration of the foregoing premises, the **PARTIES** hereby agree and bind themselves to undertake the following:

Roles & Responsibilities of the Parties:

- A. The **BFAR 6** shall:
 - Validate beneficiaries for the project(s);
 - 2. Provide funds for the inputs of the projects in accordance with the approved proposal(s) which form integral part of this agreement;
 - 3. Ensure that the projects are turned-over properly to project beneficiaries and utilized according to standard government accounting and auditing procedures;
 - 4. Require the **LGU** for the monthly submission of progress report;
 - 5. Conduct regular monitoring, validation and evaluation of the projects;
 - 6. Ensure project sustainability through continuous management of the project.

B. The **LGU** shall:

- 1. Ensure that the project inputs are turned-over properly to project beneficiaries and utilized according to standard government accounting and auditing procedures;
- 2. Provide technical support to the beneficiaries, in coordination with **BFAR6**;
- 3. Conduct regular monitoring, validation and evaluation of the projects;
- 4. Submit to **BFAR6** monthly status report of the projects and cooperate with the **BFAR6** monitoring team.

NOW, THEREFORE, on motion of HON. NORBERTO T. TURALBA, *Chairman, Committee on Agriculture and Aquatic Resources* and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan to enter into a Memorandum of Agreement (MOA) with the Bureau of Fisheries and Aquatic Resources Regional Office No. 6 for the implementation of the National Program "Targeted Action to Reduce Poverty and Generate Economic Transformation in the Fisheries Sector (TARGET)" in the Municipality Of Tigbauan,
