

RESOLUTION APPROVING AND ADOPTING THE EXECUTIVE LEGISLATIVE AGENDA (ELA) AND CAPACITY DEVELOPMENT (CAPDEV) AGENDA IN THE YEAR 2019-2022 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Executive Legislative Agenda (ELA) was conceived to serve as a "powerful vehicle for effective local governance" which may be defined as a planning document, covering a 3-year period corresponding to the term of local elective officials that is mutually developed and agreed upon by both the executive and legislative departments of an LGU;

WHEREAS, ELA is an integrated plan that contains the major development thrusts and priorities of both the executive and legislative branches of the LGU towards a common vision for the locality and an instrument that will prioritize responses to multi-stakeholder needs, e.g., programs, projects, activities, legislations and capacity development programs, and put into action local development plans;

WHEREAS, a Capacity Development (CAPDEV) Agenda outlines the capacity development strategies, programs and initiatives that need to be undertaken to address identified organizational competency gaps, indicating the target groups, specific recommended approaches, resources required and timeline;

WHEREAS, Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor of the Municipality of Tigbauan issued Executive Order No. 030, Series of 2019, Organizing the Comprehensive Development Plan and Executive-Legislative Agenda Team (CDP-ELA Team) and Designating its Composition and Functions for the Municipality of Tigbauan, Iloilo;

WHEREAS, the ELA Team formulated the Capacity Development Agenda and Executive-Legislative Agenda last August 20-23, 2019 at Acacia Hotel, Bacolod City which was participated in by coaches and resource persons from the Department of Interior and Local Government (DILG), members of ELA Team and stakeholders;
