**Resolution No. 2019-143**

RESOLUTION APPROVING AND ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT (MDRRM) CONTINGENCY PLAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, to address disasters/calamities, the Local Government Unit (LGU) shall be responsible for the monitoring through PAGASA, PHILVOCS and other agencies that have the capability of determining what possible disaster may arise;

WHEREAS, in a letter dated December 6, 2019, the Hon. Mayor, Atty. Suzette Tenefrancia-Alquisada endorsed to this August Body her request for the adoption and approval of the Municipal MDRRM Contingency Plan;

WHEREAS, the Contingency Plan is a scenario-based plan for a specific and projected natural and/or human-induced hazard and it aims to address the impacts of hazards to the people, properties and environment;

WHEREAS, as provided under Section 12 par.c.2 of R.A. 10121, one of the functions of the Municipal Risk Reduction and Management Office is to facilitate and support risk assessments and contingency planning activities at the local level with impartiality given the emerging challenges brought by disasters;

WHEREAS, the Municipal Disaster Risk Reduction and Management (MDRRM) Council shall be responsible for the formulation of Contingency Plan for the different disasters/calamities such as tsunami, typhoon, flood, fire and earthquake, storm surge, landslides and others;


NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation* and duly seconded by Hon. Dennis T. Valencia, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba and Hon. Jerry T. Tuares;

RESOLVED, to approve and adopt the Municipal Disaster Risk Reduction and Management (MDRRM) Contingency Plan of the Municipality of Tigbauan, Province of Iloilo;
