Resolution No. 2019-148

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ILOILO PROVINCIAL GOVERNMENT FOR THE ESTABLISHMENT OF SANITARY LAND FILL (SLF) IN THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, Republic Act No 9003 (R.A. 9003) otherwise known as the “Ecological Solid Waste Management Act of 2000” was passed and made into a law on January 26, 2001; pursuant to the provision of R.A. No. 7160, otherwise known as the Local Government Code, the LGU’s shall be primarily responsible for the implementation and enforcement of environmental laws;

WHEREAS, under R.A. 9003, LGU’s are mandated to implement the aforementioned law; in 2003 the Province of Iloilo has adopted the “Ecological Solid Waste Management Program”;

WHEREAS, the program promotes proper solid waste management in the whole Province and ultimately help in eradicating problems caused by garbage;

WHEREAS, under DENR Administrative Order No. 2001-34 known as the Implementing Rules and Regulations of RA 9003, rules are promulgated to prescribe the procedures and guidelines for the implementation of the law and set Guidelines on Closure and Rehabilitation of Disposal Facility;

WHEREAS, 3 years after the passage of RA 9003, the DENR issued an Administrative Order No. 2006-10, providing for Guidelines on Categorized Sanitary Landfill since no open dumping is allowed to operate;

WHEREAS, in 2016, five LGUs were issued with Notice of Violation from the DENR-Ombudsman as to the non-compliance on the provisions of RA 9003 specifically on the closure and rehabilitation of disposal/dumping site;

WHEREAS, the Province of Iloilo anticipates that clustering of common SLF is one of the immediate solutions for LGUs to be compliant on the operation and management of disposal facility;

WHEREAS, in consideration of the foregoing premises, the parties hereby agree to jointly work and cooperate effectively in the establishment of a common or clustered SLF with the following responsibilities:

A. The Iloilo Provincial Government shall:

1. *Provide Financial Assistance/Donation in the establishment of common/clustered Sanitary Landfill;*
2. *Provide technical and other forms of assistance for the successful implementation of the project;*
3. *Conduct Information, Education Campaign (IEC) and training for a sustainable management and maintenance of the disposal site;*
4. *Conduct regular monitoring and evaluation and gather footages of the project for the appropriate reporting and to make sure that the funds were appropriately utilized as stipulated in Work and Financial Plan by the Municipality of Tigbauan.*

B. The Municipality of Tigbauan shall:

1. *Prepare a Clustered Sanitary Landfill Operation and Management Plan with approved Work and Financial Plan;*
2. *Provide support funds for a sustainable management and operation of the SLF;*
3. *Responsible for the implementation of the Clustered Sanitary Landfill Operation and Management within sixty (60) days upon receiving the financial assistance/donation;*
4. *Conduct regular inspection and submit progress and development reports of the Clustered Sanitary Landfill Operation and Management and any problem which may arise and*
5. *Submit liquidation report once the project is fully accomplished based on the Work and Financial Plan.*


NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Dennis T. Valencia, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan, to Enter Into a Memorandum of Agreement With the Iloilo Provincial Government for the Establishment of Sanitary Land Fill (SLF) in the Municipality of Tigbauan;

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, to the Municipal Budget Office, to the Municipal Treasurer's Office and to the Municipal Accounting Office.
