RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH BARANGAY NAGBA TIGBAUAN, ILOILO FOR THE TRANSFER OF FUND AS FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FOR THE RIPRAPPING OF RIVERBANK NEAR THE OVERFLOW FROM MDRRM FUND ASSISTANCE TO BDRRMC.

WHEREAS, under the Local Government Code of 1991, Local Government Units are mandated to address the needs of their constituencies, and empower the people through direct participation in the affairs of government, by allowing them the widest possible space to decide on, initiate, implement, and innovate on development activities that address their identified needs;

WHEREAS, as convergence strategy, the Municipal Government of Tigbauan recognizes and appreciates the efforts and participation of the Barangay Councils in responding to the needs of their constituents;

WHEREAS, the Municipality of Tigbauan has appropriated the amount of *Five Hundred Thousand Pesos (P500,000.00)* as *Financial Assistance for the Riprapping of Riverbank near Overflow project* identified in the 2019 Supplemental Budget – Assistance to Barangay Disaster Risk Reduction and Management Council;

WHEREAS, Barangay Nagba requested for the release of the above-mentioned amount to implement the project;

WHEREAS, the amount of FIVE HUNDRED THOUSAND PESOS (P500,000.00) shall be transferred to Barangay Nagba for them to implement the said project;

WHEREAS, premises considered, the Parties hereby agree to the following:

The **Municipality of Tigbauan** will monitor and evaluate the project in coordination with the Municipal Engineering Office;

Barangay Nagba shall:

- 1. Take full responsibility in the proper disposition/disbursement of funds in the implementation in accordance with the implementing Guidelines and COA rules and regulations;
- 1. Use the funds of the Tigbauan Municipal Government solely for the implementation of the specific project;
- 2. After the assistance, the Accountable Officer shall prepare and submit to the Tigbauan Municipal Government the Statement of Expenditures duly signed by the Barangay Treasurer and verified by COA.
- 3. Complete the project within 120 calendar days (inclusive of 45 days procurement activity)
- 4. Return any unexpended balance of funds released and refund any disallowance made by the Municipal Auditor in the course of post audit transaction.

NOW, THEREFORE, on motion of HON. NORBERTO T. TURALBA, Chairman, Committee on Infrastructure and General Services and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette T. Alquisada, for and in Behalf of the Municipality of Tigbauan to Enter Into a Memorandum of Agreement With Barangay Nagba Tigbauan, Iloilo for the Transfer of Fund as Financial Assistance in the Amount of Five Hundred Thousand Pesos (P500,000.00) for the Riprapping of Riverbank Near the Overflow from MDRRM Fund Assistance to BDRRMC;
