RESOLUTION GRANTING AWARDS AND INCENTIVES TO NATIONAL GOVERNMENT AGENCIES EMPLOYEES, RESPONDER VOLUNTEERS, OSCA HEAD, AND OTHER MEMBERS OF THE DIFFERENT COUNCILS IN THE AMOUNT OF ONE THOUSAND PESOS (P1,000.00) EACH IN RECOGNITION OF THEIR VALUABLE CONTRIBUTION TO THE REALIZATION OF THE PLANS, PROGRAMS AND ACTIVITIES OF THE MUNICIPALITY FOR THE YEAR 2019.

WHEREAS, Section 3(i) of the Local Government Code provides that, *“Local government units shall share with the national government the responsibility in the management and maintenance of ecological balance within their territorial jurisdiction, subject to the provisions of this Code and national policies;”*

WHEREAS, Section 3(k) of the Local Government Code also provides that, *“The realization of local autonomy shall be facilitated through improved coordination of national government policies and programs an extension of adequate technical and material assistance to less developed and deserving local government units;”*

WHEREAS, Section 3(l) of the Local Government Code likewise provides that, *“The participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development;”*

WHEREAS, the Municipality of Tigbauan recognizes the significant contribution of personnel of the different sectors hence it is rightfully just that they shall be given incentives and awards;

WHEREAS, granting awards and incentives are hereby given to the personnel of our Philippine National Police (PNP), the Bureau of Fire Protection (BFP) for their exemplary performance in the maintenance of peace and order in the Municipality of Tigbauan specifically in the arrest of most wanted persons and for their continued commitment to advance the safety and general welfare of the people;


