RESOLUTION ADOPTING THE PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN FOR 2020-2022 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Section 116 of Republic Act No. 7160, also known as the Local Government Code of 1991, and Executive Order No. 773, s. 2009, mandate for the further reorganization of the Peace and Order Councils in every Province, City and Municipality;

WHEREAS, DILG Memorandum Circular No. 2015-128 dated November 2, 2015 entitled: Guidelines on Formulation of Peace and Order and Public Safety (POPS) Plan likewise mandates every Provincial, City, Municipal Peace and Order Council and Barangay Peace and Order Committee to formulate a three (3) year term based Peace and Order and Public Safety (POPS) Plan which shall be incorporated in the Comprehensive Development Plan (CDP) of the Local Government Unit;

WHEREAS, the Municipal Peace and Order Council Technical Working Group (MPOC-TWG) was reorganized through Executive Order No. 36 and was tasked to draft the POPS Plan for the Municipality of Tigbauan, Province of Iloilo;

WHEREAS, the MPOC TWG through a series of meetings has formulated the draft POPS Plan with a recommended budget of Six Hundred Eighty-Nine Thousand Pesos (P689,000.00), as divided into: *Peace and Order: P609,000.00* and *Public Safety: P80,000.00*;

WHEREAS, an urgent letter from the Municipal Mayor dated December 6, 2019 was received by the Office of the Sangguniang Bayan, requesting for the passage of a resolution adopting and approving the Peace and Order and Public Safety (POPS) Plan for 2020-2022 of the Municipality of Tigbauan, Province of Iloilo;


NOW THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, Committee on Peace & Order and Public Safety* and duly seconded by Hon. Dennis T. Valencia, Hon. Marlon R. Teruñez, Hon.
