RESOLUTION CONFORMING AND APPROVING THE FOLLOWING: A.) CY 2020 BARANGAY ANNUAL BUDGETS & ANNUAL INVESTMENT PLANS OF BARANGAYS BANGKAL, CORDOVA NORTE, CORDOVA SUR AND NAGBA; B.) CY 2019 SUPPLEMENTAL BUDGETS OF BARANGAYS BITAS, CORDOVA SUR AND NAPNAPAN NORTE; AND C.) CY 2020 SK ANNUAL BUDGET AND PLAN OF BARANGAY NAPNAPAN SUR, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on December 18, 2019 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the following:

a.) CY 2020 Annual Budgets & Annual Investment Plans of Barangays Bangkal, Cordova Norte, Cordova Sur and Nagba, this municipality (as hereunder provided) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace, to wit:

The appropriation of Brgy. Bangkal for the Annual Budget CY 2020 in the amount of P2,120,000.00 and 20% Development Fund in the amount of P410,384.00;

The appropriation of Brgy. Cordova Norte for the Annual Budget CY 2020 in the amount of P2,771,032.00 and 20% Development Fund in the amount of P535,606.40;

The appropriation of Brgy. Cordova Sur for the Annual Budget CY 2020 in the amount of P2,610.00 and 20% Development Fund in the amount of P485,699.00;

The appropriation of Brgy. Nagba for the Annual Budget CY 2020 in the amount of P1,930,000.00 and 20% Development Fund in the amount of P381,951.80;

b.) Barangays Bitas, Cordova Sur and Napnapan Norte CY 2019 Supplemental Budgets:

The appropriation of Brgy. Bitas for the Supplemental Budget No. 2019-04 embodying Appropriation Ordinance No. 2019-03 in the amount of P63,110.36 is chargeable against the RPT Share, Savings/Terminal Leave Benefits, of the aforementioned barangay.

The appropriation of Brgy. Cordova Sur for the Supplemental Budget No. 2019-03 embodying Appropriation Ordinance No. 2019-02 in the amount of P82,000.00 is chargeable against the PS-Savings/Surplus and 2019-Honorarium Brgy. Officials, of the aforementioned barangay.

The appropriation of Brgy. Napnapan Norte for the Supplemental Budget No. 2019-03 embodying Appropriation Ordinance No. 2019-02 in the amount of P56,821.46 is chargeable against the Savings/Surplus 2019-Terminal Leave Benefits, Honoraria-Day Care Worker, Honoraria-Health and Nutrition and Honoraria-Peace and Order, of the aforementioned barangay.

c.) CY 2020 SK Annual Budget and Plan of Barangay Napnapan Sur:

Brgy. Napnapan Sur (SK) for the Annual Budget CY 2020 in the amount of P259,300.40 and 10% General Fund in the amount of P259,300.40, shall be utilized for projects incidental to the efficient and effective provisions of basic services of the populace, to wit:

WHEREAS, the OIC-Municipal Budget Officer had reviewed in advance and endorsed to this August Body the said Barangay Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code, Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budget of the above-mentioned Barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace and the utilization thereof shall be in accordance also with Section 287 of the Local Government Code, Rule XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;


NOW, THEREFORE, on motion of HON. DENNIS T. VALENCIA, *Vice Chairman, Committee on Appropriations, Budget, Finance and Accounts* and duly seconded by Hon. Neri T. Camiña, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba and Hon. Jerry T. Tuares;

RESOLVED, to conform and approve the following: a.) CY 2020 Barangay Annual Budgets & Annual Investment Plans of Barangays Bangkal, Cordova Norte, Cordova Sur and Nagba; b.) CY 2019 Supplemental Budgets of Barangays Bitas, Cordova Sur and Napnapan Norte; and c.) CY 2020 SK Annual Budget and Plan of Barangay Napnapan Sur, this municipality.
