RESOLUTION APPROVING AND RATIFYING MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC), RESOLUTION NO. 2019-03, RESOLUTION APPROVING THE AMOUNT OF FIFTY THOUSAND (50,000) PESOS FINANCIAL ASSISTANCE FOR EACH MUNICIPALITY OF BATAD, BALASAN, ESTANCIA AND CARLES WHICH WERE AFFECTED BY TYPHOON URSULA THAT LASHED THE AREA DURING THE CHRISTMAS SEASON TO BE TAKEN FROM MDRRM QUICK RESPONSE FUND OF THE MUNICIPALITY OF TIGBAUAN, ILOILO

WHEREAS, the onset of Typhoon Ursula, brought havoc to the Central Philippines, particularly the Eastern and Western Visayas on Christmas Day, destroying homes and cutting off power with its powerful winds and flooding villages with its incessant heavy rains on what is supposed to be Christendom's happiest day;

WHEREAS, Typhoon Ursula first hit land at Salcedo, Eastern Samar at 4:45 p.m. on December 24, Tuesday then made another landfall in Tacloban City, Leyte, and in Cabucgayan, Biliran, during the night. It went on to blow toward land, hitting Gigantes Islands in Carles, Iloilo, at 2:30 a.m. on Christmas Day (December 25, Wednesday), then slamming into Ibajay, Aklan Province;

WHEREAS, the landfall in Gigantes Islands caused tremendous damages to the 5<sup>th</sup> District Municipalities of Iloilo, namely the Municipalities of Batad, Balasan, Estancia and Carles leaving large areas in shambles, with thousands losing their homes and livelihoods;

WHEREAS, as such, the Local Government Unit of Tigbauan would like to extend financial assistance to the Municipalities of Batad, Balasan, Estancia and Carles in the 5<sup>th</sup> District of Iloilo which were extremely affected by Typhoon Ursula in order to hasten the relief, recovery and rehabilitation efforts of the local government;

WHEREAS, this financial assistance will be taken from the MDRRM 30% Quick Response of the Municipality of Tigbauan;

RESOLVED, to approve and ratify Municipal Disaster Risk Reduction and Management Council (MDRRMC), Resolution No. 2019-03, Resolution Approving The Amount Of Fifty Thousand (50,000) Pesos Financial Assistance For Each Municipality Of Batad, Balasan, Estancia And Carles Which Were Affected By Typhoon Ursula That Lashed The Area During The Christmas Season To Be Taken From Mdrrm Quick Response Fund Of The Municipality Of Tigbauan, Iloilo
