WHEREAS, Article 2, Sec. 17, of the “1987 Philippine Constitution” provides that - “*The State shall give priority to Education, Science and Technology, Arts, Culture and Sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development*”;

WHEREAS, Article XIV (*Education, Science and Technology, Arts, Culture and Sports*), Sec. 1, of the 1987 Philippine Constitution also provides that - “*The State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all*”;

WHEREAS, Sec. 16, (*General Welfare*) of the Local Government Code of 1991 provides that “*Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. . . encourage and support the development of appropriate and self-reliant scientific and technological capabilities. . .*”;

WHEREAS, Tigbauan National High School of Tigbauan, Iloilo, introduced and offered Special Program in Journalism in School Year 2018-2019;

WHEREAS, this is already the 2nd year of implementation of the special program in Journalism of the Tigbauan National High School;
