## Resolution No. 2020-016

RESOLUTION CONFORMING AND APPROVING THE CY 2020 BARANGAY ANNUAL BUDGETS AND 2020 ANNUAL INVESTMENT PLANS OF BARANGAYS BINALIUAN MAYOR, ISAUAN AND LUBOG THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on January 28, 2020 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the 2020 Annual Budgets and 2020 Investment Plans of the following Barangays:

The appropriation of **Brgy. Binaliuan Mayor** for the Annual Budget CY 2020 in the amount of **P2,462,053.00** and 20% Development Fund in the amount of **P478,742.20**; to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.

The appropriation of **Brgy.** Lubog for the Annual Budget CY 2020 in the amount of **P1,740,000.00** and 20% Development Fund in the amount of **P341,420.80**; to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.
