RESOLUTION AUTHORIZING HONORABLE SUZETTE T. ALQUISADA, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION AND ACCEPTANCE WITH THE ILOILO PROVINCIAL GOVERNMENT FOR THE DONATION OF ONE (1) UNIT COMPUTER SET FOR THE IMPLEMENTATION OF THE ELECTRONIC MANPOWER AND SKILLS REGISTRY SYSTEM (eMSRS) AND PESO PROGRAMS AND ACTIVITIES.

WHEREAS, the Department of Labor and Employment (DOLE) has initiated the National Skills Registration Program (NSRP) with the main objective of maintaining a continuing nationwide skills registry through its Skills Registry System (SRS) database;

WHEREAS, the PESO Employment Information System (PEIS) is the enhanced version of the Skills Registry System. It is a database of active manpower supply containing the profiles of all persons and employers registered under the NSRP;

WHEREAS, the Public Employment Service Office of the Iloilo Provincial Government has developed an employment tracking system to track basic employment information of successful applicants deployed for local and overseas work, purposely for profiling and monitoring. The Electronic Manpower Registry (eMSR) will also serve as our local repository on available manpower supply in the Province of Iloilo. It will show information on the qualifications and skills of the applicants as well as the job vacancies posted by the employers. This registry is maintained and updated by all participating PESO's, including that of LGU Tigbauan, Iloilo;

WHEREAS, the Local Employment Service Office of the Municipality of Tigbauan cannot fully implement their programs and mandates for lack of the necessary hardware;

WHEREAS, Banco de Oro (BDO) donated 45 computers to the Iloilo Provincial Government in a ceremonial turn-over on Aug. 9, 2019. The hardware will be distributed in the form of a donation to the 42 towns and one component city while the remaining two will be utilized by PESO in implementing the electronic Manpower and Skills Registry System (eMSRS). LGU Tigbauan is one of the identified recipients thereof;


NOW, THEREFORE, on motion of HON. JULIUS T. LEDESMA, *Chairman, Committee On Economic Affairs, Investment And Labor and Employment* and duly seconded by Hon. Dennis T. Valencia, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

BE IT RESOLVED, as it is hereby resolved, to authorize Honorable Suzette T. Aquisada, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan to enter into a Deed of Donation and Acceptance with the Iloilo Provincial Government for the Donation of One (1) Unit Computer Set for the Implementation of the Electronic Manpower and Skills Registry System (eMSRS) and Peso Programs and Activities.


RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, the Iloilo Provincial Government and all concerned for their information and/or appropriate action.
