**Resolution No. 2020-023**

RESOLUTION CONFORMING AND APPROVING THE CY 2020 BARANGAY ANNUAL BUDGETS AND 2020 ANNUAL INVESTMENT PLANS OF BARANGAYS BAGUMBAYAN, BAROSONG, NAPNAPAN SUR AND SAN RAFAEL, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on February 11, 2020 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the 2020 Annual Budgets and 2020 Investment Plans of Barangays Bagumbayan, Barosong, Napnapan Sur and San Rafael, this municipality, to wit:

*The appropriation of **Brgy. Bagumbayan** for the Annual Budget CY 2020 in the amount of **P2,825,000.00** and 20% Development Fund in the amount of **P545,236.80**; to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.*

*The appropriation of **Brgy. Barosong** for the Annual Budget CY 2020 in the amount of **P2,436,000.00** and 20% Development Fund in the amount of **P468,212.80**; to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.*

*The appropriation of **Brgy. Napnapan Sur** for the Annual Budget CY 2020 in the amount of **P2,625,000.00** and 20% Development Fund in the amount of **P504,300.80**; to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.*

*The appropriation of **Brgy. San Rafael** for the Annual Budget CY 2020 in the amount of **P1,610,000.00** and 20% Development Fund in the amount of **P318,091.80**; to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.*

WHEREAS, the OIC-Municipal Budget Officer had reviewed in advance and endorsed to this August Body the said Barangay Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code, Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No.

2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
