RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION WITH THE DEPARTMENT OF HEALTH (DOH) FOR THE DONATION OF ONE (1) UNIT AMBULANCE INCLUDING EQUIPMENT AMOUNTING TO TWO MILLION FOUR HUNDRED FIFTY THOUSAND PESOS (P2,450,000)

WHEREAS, the State recognizes its mandate to provide equitable and accessible quality healthcare for all Filipinos;

WHEREAS, *Boosting Universal Health Care via FOURmula One for Health Plus* envisions quality health care to be more accessible to the poor and vulnerable population by ensuring the availability of functional health care facilities;

WHEREAS, the Health Facilities Enhancement Program (HFEP) aims to improve the delivery of health services through the updating of health facilities and provision of medical equipment in order to make them more responsive to the health needs of the population;

WHEREAS, the provision of ambulance shall contribute to the functionality of the health system and the delivery of quality health care;

WHEREAS, the Local Government Units are the partners of the DOH in implementing health programs and in delivering quality health services;

WHEREAS, in consideration of the foregoing premises and subject to the conditions stipulated hereunder, the Department of Health hereby donates to the Municipality of Tigbauan, one (1) unit Ambulance including the equipment therein amounting to Two Million Four Hundred Fifty Thousand Pesos (P2,450,000.00);

WHEREAS, the Local Government Unit of Tigbauan accepts the donation and undertakes to:

1. *Ensure that the ambulance is properly classified and recorded in the books of assets of the LGU or health facility;*
2. *Ensure that within six (6) months upon receipt of the ambulance, said ambulance is licensed in its name and at its own expense, in accordance with the DOH Administrative Order regarding the Rules and Regulations Governing the Licensure of Land Ambulances and Ambulance Service Providers;*
3. *Ensure the availability of health personnel, supplies and other operational expenses necessary for the operation and maintenance of the ambulance and the equipment therein;*
4. *Ensure that the ambulance is utilized in accordance within the definition and standards provided in the abovementioned DOH Administrative Order;*
5. *Ensure the rational use of the ambulance within the municipality or locality to maximize its benefit to the residents needing ambulance service;*
6. *Apply for the renewal of the ambulance vehicle registration with the Land Transportation Office (LTO) after three years (3) using its own resources. The Donee may transfer the vehicle registration under its name;*
7. *Designate the MHO//CHO/PHO/LGU as the focal person who will be coordinating with the DOH Regional office for purposes of program monitoring and evaluation.*


NOW THEREFORE, on motion of HON. SUZETTE MARIE HILADO-BANNO, *Chairperson, Committee on Health and Sanitation* and duly seconded by Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette T. Alquisada, for and in behalf of the Municipality of Tigbauan to enter into a Deed of Donation with the Department of Health (DOH) for the donation of one (1) unit ambulance including equipment amounting to Two Million Four Hundred Fifty Thousand Pesos (P2,450,000).

RESOLVED FURTHER, to furnish copies of this Resolution to the Department of Health (DOH), to Hon. Suzette T. Alquisada, Municipal Mayor and to all concerned for their information.
