RESOLUTION ADOPTING THE ANNUAL BUDGET OF THE LOCAL SCHOOL BOARD (LSB) OF THE MUNICIPALITY OF TIGBAUAN FOR CALENDAR YEAR 2020 IN THE AMOUNT OF FOUR MILLION PESOS (P4,000,000.00);

WHEREAS, R.A. 7160 otherwise known as Local Government Code of 1991, Section 99 (a) provides that the Local School Board shall determine, in accordance with the criteria set by the *Department of Education, Culture and Sports*, the annual supplementary budgetary needs for the operation and maintenance of public schools within the province, city, or municipality, as the case may be, and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the Special Education Fund and such other sources of revenue as this Code and other laws or ordinances may provide;

WHEREAS, the Local School Board approved its Budget for 2020 allocating this year's Special Education Fund (SEF) for the following purposes:

Function/Program/Project/Activity	Appropriations
Repair & Maintenance of School Buildings & Other Facilities/ Acquisition of facilities and equipment	P2,300,000.00
Sports and Cultural Development (Trainings, Purchase of Sports Equipment, Contribution to host municipality for CDSA, and all other expenses for sports and cultural activities at the national, regional, division, district, municipality and barangay levels)	P1,500,000.00
Literacy, Values and ALS Programs (includes research, purchase of learning materials and other expenses)	P 200,000.00
GRAND TOTAL	P4,000,000.00


