Binaliuan Menor** CY 2020 General Annual Budget Involving an Appropriation of P1,918,000.50 and 20% Development Fund in the amount of P379,559.80, 10% SK Fund in the amount of P191,800.05, 5% BDRRMF in the amount of P95,900.03 and GAD Attribution in the amount of P234,677.99 Approved by the Sangguniang Barangay on December 15, 2019 and enacted by the Appropriation Ordinance No. 2019-01;

**Brgy. Olo Barroc** CY 2020 General Annual Budget Involving an Appropriation of P1,657,000.50 and 20% Development Fund in the amount of P323,075.80, 10% SK Fund in the amount of P165,700.05, 5% BDDRM in the amount of P82,850.03 and GAD Attribution in the amount of P157,033.79 Approved by

the Sangguniang Barangay on December 15, 2019 and enacted by the Appropriation Ordinance No. 2019-01;

Brgy. Parara Sur CY 2020 General Annual Budget Involving an Appropriation of P3,446,000.50 and 20% Development Fund in the amount of P664,850.20, 10% SK Fund in the amount of P344,600.05, 5% BDRRMF in the amount of P172,300.03 and GAD Attribution in the amount of P573,942.51 Approved by the Sangguniang Barangay on December 10, 2019 and enacted by the Appropriation Ordinance No. 2019-01;
