RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HONORABLE ARTHUR R. DEFENSOR, JR., GOVERNOR, PROVINCE OF ILOILO IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FOR THE IMPLEMENTATION OF CORONA VIRUS DISEASE 2019 (COVID-19) PREVENTIVE MEASURES IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Proclamation No. 929 was issued on March 16, 2020 by the President of the Philippines, entitled: *“Declaring A State Of Calamity Throughout The Philippines Due To Corona Virus Disease 2019”* for a period of six (6) months, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, Executive Order No. 028-C, S. 2020 was likewise issued on March 10, 2020 by the Iloilo Provincial Governor, Hon. Arthur Defensor, Jr., entitled: *“An Order Further Strengthening the Imposition of Quarantine Procedures and Disease Prevention and Control Measures To Protect the Province of Iloilo Against the Corona Virus Disease 2019 (COVID-2019);”*

WHEREAS, despite government efforts and interventions, the number of confirmed cases of COVID-19 continue to rise;

WHEREAS, owing to the urgency of the developing situation, the Department of Health (DOH) and the Inter-Agency Task Force for Emerging Infectious Diseases (IATF) had placed the country on Code Red, Sub- level 2;

WHEREAS, because of this extra-ordinary situation, the members of this August Body, pursuant to the letter request of the good Mayor, decided on consensus to request financial assistance from the good Governor, for the implementation of COVID-19 preventive measures of the Municipality;


