Brgy. 7 Poblacion CY 2020 General Annual Budget Involving an Appropriation of P2,448,000.50 and 20% Development Fund in the amount of P464,286.20, 10% SK Fund in the amount of P244,800.05, 5% BDRRMF in the amount of P122,400.03 and GAD Attribution in the amount of P363,814.31 Approved by the Sangguniang Barangay on December 8, 2019 and enacted by the Appropriation Ordinance No. 2019-02;

Brgy. Buenavista CY 2020 General Annual Budget Involving an Appropriation of P1,850,000.50 and 20% Development Fund in the amount of P365,967.40, 10% SK Fund in the amount of P185,000.05, 5% BDDRM in the amount of P92,500.03 and GAD Attribution in the amount of P229,998.37 Approved by the Sangguniang Barangay on December 15, 2019 and enacted by the Appropriation Ordinance No. 2019-01;

Brgy. Dapdap CY 2020 General Annual Budget Involving an Appropriation of P1,900,000.50 and 20% Development Fund in the amount of P368,232.80, 10% SK Fund in the amount of P190,000.05, 5% BDRRMF in the amount of P95,000.03 and GAD Attribution in the amount of P245,411.64 Approved by the Sangguniang Barangay on December 15, 2019 and enacted by the Appropriation Ordinance No. 2019-02;

b.) CY 2019 SK Supplemental Budget of Barangay Napnapan Sur:

The appropriation of **Brgy. Napnapan Sur** for the Supplemental Budget No. 2019-01 embodying Appropriation Ordinance No. 2019-01 in the amount of **P175,444.30** (*MOOE is for the payment of Travelling Expenses, Training Expenses, Cultural Activities, Furniture and Fixtures, Building Construction,*

Plastic Baylo- Bugas Project, Sports League, and 4-H Club Activities and Programs) chargeable against RPT Share, SK Savings, Surplus CY 2018-2019 and IRA Increase 10% Share of the aforementioned barangay.
