Resolution No. 2020-035

RESOLUTION SUSPENDING RULE VII-SECTION 1 (a) OF S.B.s INTERNAL RULES OF PROCEDURE ON SCHEDULE OF REGULAR SESSION UNTIL APRIL 15, 2020 TO MEET THE EXIGENCY OF SERVICE DUE TO COVID 19-PANDEMIC.

WHEREAS, Section 1 paragraph (a) of Rule VII of S.B.s Internal Rules of Procedure provides:

- (a) *"The regular session shall be held every **Wednesday** and shall start promptly at 1:30 in the afternoon. Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day."*

WHEREAS, in support of the fight against COVID 19 pandemic, the Municipal Mayor, Atty. Suzette Tenefracia-Alquisada issued on March 26, 2020 Office Memorandum No. 2020-002, to all elective officials, permanent employees and JOP's with the subject: **"Adoption of Work at Home Arrangement and Skeletal Force"**

WHEREAS, one of the guidelines as stated in said Office Memorandum is to *"(5.) Maintain a skeletal staff of not more than 50% daily to decongest the office, strictly maintain social distancing and reduce exposure of employees."*

WHEREAS, Proclamation No. 922 was issued on March 8, 2020 by the President of the Philippines, entitled: *"Declaring a State of Public Health Emergency Throughout the Philippines;"*

WHEREAS, Proclamation No. 929 was issued on March 16, 2020 by the President of the Philippines, entitled: *"Declaring A State Of Calamity Throughout The Philippines Due To Corona Virus Disease 2019"* for a period of six (6) months, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, Executive Order No. 028-C, S. 2020 was likewise issued on March 10, 2020 by the Iloilo Provincial Governor, Hon. Arthur Defensor, Jr., entitled: *“An Order Further Strengthening the Imposition of Quarantine Procedures and Disease Prevention and Control Measures To Protect the Province of Iloilo Against the Corona Virus Disease 2019 (COVID-2019);”*

WHEREAS, because of this extra-ordinary situation, the members of this August Body, decided on consensus to suspend Rule VII-Section 1(a) of S.B.s Internal Rules of Procedure on schedule of regular session until April 15, 2020 to meet the exigency of service due to COVID-19 pandemic;


NOW, THEREFORE, on motion HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, Vice Chairperson, Committee on Rules, Ordinances, Resolutions and Legal Matters (*under the sponsorship of Vice Mayor, Atty. Virgilio T. Teruel, Committee Chairman*) and duly seconded by Hon. Dennis Valencia, Hon. Marlon Teruñez, Hon. Reynaldo Tumabotabo, Hon. Julius Ledesma, Hon. Norberto Turalba, Hon. Jerry Tuares and Hon. Dyossa Marie Teruñez;

RESOLVED, to suspend Rule VII-Section 1 (a) of S.B.S Internal Rules of Procedure on Schedule of Regular Session Until April 15, 2020 to Meet the Exigency of Service Due to COVID-19 Pandemic;

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada and to all concerned for their information.
