**Resolution No. 2020-037**

RESOLUTION DECLARING AS **LEGAL AND VALID** BARANGAY ORDINANCE NO. 07 S. OF 2019 - ***“AN ORDINANCE PENALIZING ANY INDIVIDUAL OR GROUP OF PERSON THROWING BROKEN GLASS BOTTLES AND ANY SHARP & POINTED OBJECTS TO BEACHLINE, PUBLIC ROADS, HIGHWAY AND PUBLIC PLACES AND IMPLEMENTING PENALTIES FOR THE VIOLATION THEREOF”*** OF BARANGAY BUYU-AN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the above-mentioned Barangay Ordinance was referred to the S.B. Committee on Rules, Ordinances, Resolutions and Legal Matters for review and recommendation last March 19, 2020 and the Committee has the following findings, to wit:

The ordinance was accordingly presented in a barangay assembly last March 24, 2019 and is consistent with the provisions of Section 391 of the Local Government Code, to wit:

*SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:*

- (1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;*
- (24) Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance;*

WHEREAS, the same is also consistent with SECTION 16 of the LGC which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.


NOW, THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, Committee Vice Chairman (*under the sponsorship of Hon. Virgilio T. Teruel, Chairman, Committee on Rules, Ordinances, Resolutions and Legal Matters*) and duly seconded by Hon. Dennis T. Valencia, Hon. Marlon Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to declare as **Legal** and **Valid** Barangay Ordinance No. 07 S. of 2019 - "*An Ordinance Penalizing Any Individual or Group of Persons Throwing Broken Glass Bottles and Any Sharp and Pointed Objects to Beachline, Public Roads, Highway and Public Places and Implementing Penalties for the Violation Thereof*" of Barangay Buyu-an, Municipality of Tigbauan, Province of Iloilo;
