RESOLUTION CONFORMING AND APPROVING THE CY 2020 BARANGAY ANNUAL BUDGETS AND 2020 ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT FUND, 10% SK FUND, 5% BDRRMF AND GAD ATTRIBUTIONS OF BARANGAYS BAGUINGIN, 2-POBLACION, BUGASONGAN, GUISIAN ANG TAN PAEL, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on April 14, 2020 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the 2020 Annual Budgets and 2020 Investment Plans, 20% Development Fund, 10% SK Fund 5% BDRRMF and GAD Attributions of Barangays Baguingin, 2-Poblacion, Bugasongan, Guisian and Tan Pael, this municipality, to wit:

Baguingin CY 2020 General Annual Budget Involving an Appropriation of P3,960,000.50 and 20% Development Fund in the amount of P772,381.60, 10% SK Fund in the amount of P396,000.05, 5% BDRRMF in the amount of P198,000.03 and GAD Attribution in the amount of P780,419.08 Approved by the Sangguniang Barangay on December 14, 2019 and enacted by the Appropriation Ordinance No. 2019-02;

Brgy. 2 Poblacion CY 2020 General Annual Budget Involving an Appropriation of P2,246,000.50 and 20% Development Fund in the amount of P436,497.20, 10% SK Fund in the amount of P224,600.05, 5% BDDRM in the amount of P112,300.03 and GAD Attribution in the amount of P307,424.86 Approved by the Sangguniang Barangay on December 14, 2019 and enacted by the Appropriation Ordinance No. 2019-01;

Brgy. Bugasongan CY 2020 General Annual Budget Involving an Appropriation of P1,497,000.50 and 20% Development Fund in the amount of P297,854.20, 10% SK Fund in the amount of P149,700.05, 5% BDRRMF in the amount of P74,850.03 and GAD Attribution in the amount of P131,792.71 Approved by the Sangguniang Barangay on December 11, 2019 and enacted by the Appropriation Ordinance No. 2019-01;

Brgy. Guisian CY 2020 General Annual Budget Involving an Appropriation of P1,561,000.50 and 20% Development Fund in the amount of P308,728.20, 10% SK Fund in the amount of P156,100.05, 5% BDDRM in the amount of P78,050.03 and GAD Attribution in the amount of P177,436.41, Approved by the Sangguniang Barangay on December 15, 2019 and enacted by the Appropriation Ordinance No. 2019-01;

Brgy. Tan Pael CY 2020 General Annual Budget Involving an Appropriation of P2,426,000.50 and 20% Development Fund in the amount of P462,322.80, 10% SK Fund in the amount of P242,600.05, 5% BDRRMF in the amount of P121,300.03 and GAD Attribution in the amount of P300,116.14 Approved by the Sangguniang Barangay on December 13, 2019 and enacted by the Appropriation Ordinance No. 2019-01;

WHEREAS, the OIC-Municipal Budget Officer had reviewed in advance and endorsed to this August Body the said Barangay Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code, Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
