## Resolution No. 2020-042

RESOLUTION URGING THE LOCAL CHIEF EXECUTIVE, ATTY. SUZETTE T. ALQUISADA TO GRANT FINANCIAL ASSISTANCE TO ALL BARANGAY OFFICIALS, ELECTED AND APPOINTED, AS FRONT-LINERS IN THE FIGHT AGAINST CORONAVIRUS DISEASE 2019 (COVID-19) PANDEMIC IN THE AMOUNT OF NOT MORE THAN P2,000.00 EACH

WHEREAS, the Bayanihan to Heal as One Act, officially designated as Republic Act No. 11469, is a law in the Philippines that was enacted in March 2020 granting the President additional authority to combat the 2020 coronavirus pandemic in the Philippines;

WHEREAS, under said law, a total of ₱200 billion was instituted by the national government under the **Social Amelioration Program**. The Department of Social Welfare and Development was tasked to administer the distribution of the emergency subsidies to indigent families affected by the COVID-19 pandemic in the country;

**WHEREAS,** under said program, barangay officials, both elected and appointed were excluded from the list of its probable recipients, although they have been working hard as front-liners in the fight against COVID - 19 pandemic;

WHEREAS Governor Arthur Defensor Jr., issued Executive Order No.081-A, "An Order Amending Guidelines For The Release Of Financial Assistance To The City/Municipalities In The Province Of Iloilo Due To COVID-19" in the amount of Five Million, Seven Hundred Two Thousand and Five Hundred Fifty Six Pesos (P 5,702,556.00) for the Municipality of Tigbauan, Province of Iloilo, thus, said amount shall go directly to the Trust Fund of this municipality;

WHEREAS, under the guidelines on the utilization of funds as financial assistance from the Provincial Government of Iloilo, the "giving of financial assistance to household and families affected by COVID-19 not covered by the social amelioration program", was among the allowed expenditures; **WHEREAS**, out of the total amount of Five Million Seven Hundred Two Thousand and Five Hundred Fifty Six Pesos (P5,702,556.00) received by the Municipality of Tigbauan from the "Financial Assistance to the City/Municipalities due to COVID-19 of the Province of Iloilo" there is an unexpended amount of One Million Three Hundred Thousand (P1,300,000.00) Pesos intended for other programs, projects and activities in the fight against COVID-19;

WHEREAS, there is a need to extend financial assistance to all barangay officials: 52 Punong Barangays, 364 Barangay Kagawads, 52 Secretaries, 52 Treasurers and 52 SK Chairmen for a total number of 572 Beneficiaries, who have been working 24/7 to keep a COVID-free community all days of the week for the duration of this pandemic;

**NOW, THEREFORE**, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, Committee on Appropriations, Budget, Finance and Accounts* and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

**RESOLVED**, to urge the Local Chief Executive, Atty. Suzette T. Alquisada to grant financial assistance to all barangay officials, elected and appointed, as front-liners in the fight against coronavirus disease 2019 (COVID-19) pandemic in the amount of not more than P2,000.00 each;

**RESOLVED FURTHER**, to forward a copy of this Resolution to **ATTY. SUZETTE T. ALQUISADA**, Municipal Mayor, for her immediate and appropriate action.
