RESOLUTION TO GRANT HAZARD PAY TO ALL EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN WHO HAVE RENDERED ACTUAL SERVICE DURING THE PERIOD OF COVID-19 ENHANCED COMMUNITY QUARANTINE.

WHEREAS, President Rodrigo Roa Duterte signed Administrative Order No. 26 on March 23, 2020, granting hazard pay (COVID-19 Hazard Pay) to government personnel who report for work, with retroactive application beginning March 17, 2020;

WHEREAS, the directive under Administrative Order No. 26, entitles authorized government personnel who occupy regular, contractual or casual positions in the government agencies, including local government units, as determined by their respective sanggunians, a hazard pay of not exceeding P500 a day per person. Personnel under a contract of service, job order or similar schemes are also qualified;

WHEREAS, for personnel who are already entitled to Hazard Pay, under existing laws, issuances, rules, and regulations, such as public health workers, social workers, they shall continue to be entitled to such benefits or the COVID-19 Hazard Pay, whichever is higher, provided that, they shall be paid with the balance, in case they are receiving a lower rate;

WHEREAS, the Local Finance Committee of the LGU Tigbauan has certified to the availability of Funds from savings from Personal Services Appropriation for the Year 2020;

WHEREAS, a total amount of Two Million (P2,000,000.00) from the savings has been earmarked for the payment of the Covid-19 Hazard Pay;

GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, Committee on Appropriations, Budget, Finance & Accounts and Committee On Education, Tourism and Civil Service*, and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to grant Hazard Pay to all employees of the Local Government Unit of Tigbauan who have rendered Actual Service during the period of the COVID-19 Enhanced Community Quarantine;

RESOLVED FURTHER, to forward a copy of this Resolution to Honorable Suzette T. Alquisada, Municipal Mayor and the Sangguniang Panlalawigan, Province of Iloilo for their immediate and appropriate action.
