RESOLUTION CONCURRING WITH THE APPOINTMENT OF **MR. JAN LESTER T. TIQUIO** AS LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER III (LDRMO III) OF THE LOCAL GOVERNMENT UNIT OF TIGBAUAN, EFFECTIVE JUNE 1, 2020.

WHEREAS, Mr. Jan Lester T. Tiquio was appointed as LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER III (LDRMO III) SG-18, by the Local Chief Executive on June 1, 2020 to serve as Head of the Municipal Disaster Risk Reduction Management Office of the Local Government of Tigbauan;

WHEREAS, it is just necessary and appropriate to fill up the position in the best interest of the service, due to the existence of a vacancy of the position;


