RESOLUTION AMENDING RULE VII, SECTION 1(a) OF THE S.B.'S INTERNAL RULES OF PROCEDURE PER RESOLUTION NO. 2019-070, BY TRANSFERRING THE REGULAR SESSION TIME EVERY **WEDNESDAY** FROM 1:30 IN THE AFTERNOON TO **9:00 O'CLOCK IN THE MORNING**

WHEREAS, Rule VII, Section 1, par. (a), of Resolution No. 2019-070 provides:

“Section 1. **REGULAR SESSION**

(a) *The regular session shall be held every **Wednesday** and shall **start promptly at. 1:30 in the afternoon.** Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day.”*

WHEREAS, for purposes of convenience and efficiency in the delivery of basic services, the members of this August Body agreed on consensus to amend Rule VII-Section 1(a) of their Internal Rules of Procedure by transferring the time of the regular session every **Wednesday** from 1:30 in the afternoon to **9:00 o'clock in the morning** to facilitate promptness of the legislative action;

RESOLVED, to amend Rule VII, Section 1(a) of S.B.'S Internal Rules Of Procedure per Resolution No. 2019-070, by transferring the Regular Session time every **Wednesday** from 1:30 in the afternoon to **9:00 o'clock in the morning**;
