RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ILOILO PROVINCIAL GOVERNMENT, REPRESENTED BY HON. ARTHUR R. DEFENSOR JR., GOVERNOR OF THE PROVINCE OF ILOILO, FOR THE REPAIR AND RENOVATION OF THE MILK PROCESSING PLANT LOCATED IN THE MUNICIPALITY OF TIGBAUAN TO BE USED AS COMMON QUARANTINE FACILITY/DESIGNATED ISOLATION FACILITY.

WHEREAS, the President issued Proclamation No. 922 dated March 8, 2020, "*Declaring a State of Public Health Emergency Throughout the Philippines*", in view of the COVID-19 public health situation;

WHEREAS, Section 2 of Proclamation No. 922, s. 2020, states that all government agencies and LGUs are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the Covid-19 threat";

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular No. 2020-064 dated March 29, 2020 provides for the identification and/or establishment of municipal special care facilities and isolation units amid the COVID-19 pandemic;

WHEREAS, the same Memorandum enjoined all local chief executives to immediately identify, designate and establish their respective COVID-19 Special Care Facilities, in support to the Inter Agency Task Force Resolution No. 16 provision;

WHEREAS, the FIRST PARTY owns the buildings and lot previously used as Iloilo Milk Processing Plant operated by the Iloilo Federation of Dairy Cooperatives (IFEDCO) located at TNHS Compound, Barangay 4, Tigbauan, Iloilo;

WHEREAS, this building is no longer used and upon evaluation of the facilities and the location, it is adequate to be converted into a quarantine or isolation facility for COVID-19;

NOW, THEREFORE, for and in consideration of the foregoing premises, hereinafter set forth, the PARTIES hereby agree as follows:

I. ROLES AND RESPONSIBILITIES OF THE PARTIES

A. THE LGU-TIGBAUAN shall:

- 1. Submit a budget proposal to the FIRST PARTY upon entering into this Memorandum of Agreement;
- 2. Start with the project upon receiving the funds from the FIRST PARTY and shall appropriate local funds if necessary for the completion of the project;
- 3. Ensure quality and cost-effective repair and maintenance of the building;
- 4. Ensure that the facility is equipped with appropriate furniture and beds, with sufficient provisions for electricity and running water, kitchen, toilets and baths;
- 5. Ensure that health, emergency and security personnel are made available whenever necessary and that health protocols and security measures are strictly implemented;
- 6. Take full responsibility in the proper disposition/disbursement of funds in accordance with existing accounting and auditing rules and regulations imposed by the Commission on Audit (COA), and other applicable accounting and auditing manuals used by the Government.

B. The ILOILO PROVINCIAL GOVERNMENT shall:

- 1. Provide for financial assistance to the SECOND PARTY upon entering into this Memorandum of Agreement and upon receiving and approval of the budget proposal;
- 2. Shall allow the SECOND PARTY to do repair and maintenance of the building and use it for the intended purpose; and
- 7. Shall require the SECOND PARTY to submit liquidation of funds report in accordance with existing accounting and auditing rules and regulations imposed by the Commission on Audit (COA), and other applicable accounting and auditing manuals used by the Government.

NOW, THEREFORE, on motion of HON. NORBERTO T. TURALBA, Chairman, Committee on Infrastructure & General Services (under the sponsorship of the Committee on Infrastructure & General Services jointly with the Committee on Health & Sanitation chaired by Hon. Suzette Marie Hilado-Banno); and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, for and in behalf of the Municipality of Tigbauan, to enter into a Memorandum of Agreement with the Iloilo Provincial Government, represented by Hon. Arthur R. Defensor Jr., Governor of the Province of Iloilo, for the repair and renovation of the Milk Processing Plant located in the Municipality of Tigbauan to be used as Common Quarantine Facility/Designated Isolation Facility.
