b.) CY 2019 Supplemental Budget of Barangays 3 Poblacion and Cordova Sur to wit:

Brgy. Buenavista CY 2020 SK Annual Budget Involving an Appropriation of P567,349.65, 10% General Fund in the amount of P185,000.05 and continuing SK Fund in the amount of P382,349.60, approved by the Sangguniang Kabataan on May 12, 2020;

Brgy. Dorong-an CY 2020 SK Annual Budget Involving an Appropriation of 323,300.05, 10% General Fund in the amount of P3323,300.05, approved by the Sangguniang Kabataan on January 5, 2020;

Brgy. Parara Norte CY 2020 SK Annual Budget Involving an Appropriation of P726,043.62 , 10% General Fund in the amount of P309,500.00 and continuing SK Fund in the amount of P416,543.62, approved by the Sangguniang Kabataan on October 27, 2019;
