RESOLUTION ADOPTING AND APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2020 FOR THE PROCUREMENT OF COVID-19 RESPONDER VEHICLE FOR THE USE OF MDRRMC IN THE AMOUNT OF ONE MILLION SIX HUNDRED THOUSAND PESOS (P1,600,000.00), PROCUREMENT OF COVID-19 MONITORING VEHICLE FOR THE USE OFPNPIN THE AMOUNT OFONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00), CONSTRUCTION OF ISOLATION FACILITY IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) AND OTHER SUPPLIES AND EQUIPMENT FOR COVID-19 RESPONSE IN THE AMOUNT OF TWO HUNDRED TWENTY-ONE THOUSAND ONE HUNDRED SIXTY-EIGHT PESOS AND SIX CENTAVOS (P221,168.06) AND PROVINCIAL FUND IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) WITH A GRAND TOTAL SUPPLEMENTAL AIP CY 2020 IN THE AMOUNT OF FIVE MILLION THREE HUNDRED TWENTY-ONE THOUSAND SIX HUNDRED EIGHTY-EIGHT PESOS AND SIX CENTAVOS (P5,321,688.06) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.”

**WHEREAS**, the Philippines was declared to be under a state of Public Health Emergency by virtue of Presidential Proclamation No. 922, s. 2020, due to the Coronavirus Disease 2019 (COVID-19) and the Code Alert System for COVID-19 was raised Code Red Sublevel Two (2) in accordance with the recommendation of the Department of Health (DOH) and the Inter-Agency Task Force for Emerging Infectious Diseases (IATF). Later, the country was also declared to be under a State of Calamity by virtue of Presidential Proclamation No. 929, s. 2020, because of the continuing COVID-19 Pandemic;

**WHEREAS**, under both proclamations all government agencies and LGUs are enjoined to render full assistance to and cooperation with each other and to mobilize the necessary resources to undertake critical, urgent, and appropriate disaster response aids and measures in a timely manner to curtail and eliminate the threats of COVID-19;

**WHEREAS**, there is a need for a Supplemental Annual Investment Program (AIP) for CY 2020 to provide for the Procurement of Covid-19 Responder Vehicle for the use of MDRRMC in the amount of **One Million Six Hundred Thousand Pesos (P1,600,000.00)**,

Procurement of Covid-19 Monitoring Vehicle for the use of PNP in the amount of **One Million Five Hundred Thousand Pesos (P1,500,000.00)**,Construction of Isolation Facility in the amount of **One Million Pesos (P1,000,000.00)** and Other Supplies and Equipment for Covid-19 Response in the amount of **Two Hundred Twenty-One Thousand One Hundred Sixty-Eight Pesos and Six Centavos (P221,168.06)** and Provincial Fund in the amount of **One Million Pesos (P1,000,000.00)** with a grand total Supplemental AIP CY 2020 in the amount of **Five Million Three Hundred Twenty-One Thousand Six Hundred Eighty-Eight Pesos and Six Centavos (P5,321,688.06)** of the Municipality of Tigbauan;
