RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH SOUTHEAST ASIAN FISHERIES DEVELOPMENT CENTER (SEAFDEC) FOR THE REGULAR COLLECTION OF SEGREGATED WASTE (RESIDUALS ONLY) OF SEAFDEC FACILITY.

WHEREAS, Republic Act No. 9003 otherwise known as the “Ecological Solid Waste Management Act of 2000” was passed and made into a law on the 26th day of January 2001; pursuant to the provision of R.A. No. 7160, otherwise known as the Local Government Code, the LGU’s shall be primarily responsible for the implementation and enforcement of environment laws;

WHEREAS, under RA 9003, LGUs are mandated to implement the aforementioned law; in 2014 the Sangguniang Bayan of the Municipality of Tigbauan passed Municipal Ordinance No. 2014-010 – “An Ordinance Enacting the Environment Code of the Municipality of Tigbauan, Province of Iloilo;”

WHEREAS, it is hereby declared the policy of the State to adopt a systematic, comprehensive and ecological solid waste management program which shall ensure the proper segregation, collection, transport, treatment and disposal of the best environmental practice in ecological waste management excluding incineration;

WHEREAS, Solid Waste Management is one of the major thrusts of the Local Government Unit of Tigbauan in line with its vision for an ecologically balanced environment;

WHEREAS, SEAFDEC AQD is the premier international aquaculture research center in the Philippines;

WHEREAS, the municipal government is regularly collecting segregated wastes especially in the Poblacion areas and in its coastal barangays;

WHEREAS, SEAFDEC ACQ requested for a regular collection for their segregated wastes to ensure the cleanliness of their facility;

WHEREAS, for and in consideration of the foregoing premises hereinafter set forth, the parties hereto agree to undertake the regular garbage collection under the following terms and conditions:

ROLES AND RESPONSIBILITIES:

LOCAL GOVERNMENT UNIT shall:

1. Consider the collection of the segregated wastes (residual only) of SEAFDEC AQD every last Friday of the month or wherever the need arises;
2. Segregated residual wastes shall only be collected by the garbage collectors of the municipality;
3. Monitor the implementation of the segregated waste garbage disposition.

SEAFDEC AQD shall:

1. Ensure the proper segregation of wastes before collection;
2. Coordinate with the LGU with regard to the management and schedule of garbage collection;
3. Undertake to pay the amount of One Thousand (P1,000.00) Pesos per ton (*this includes garbage truck, gasoline, and provision allowance*).

WHEREAS, as stated in the MOU, an escalation interest of five percent (5%) per annum shall be imposed;



RESOLVED, to authorize the Municipal Mayor, Atty. Suzette T. Alquisada, for and in Behalf of the Municipality of Tigbauan to Enter into a Memorandum of Understanding (MOU) With Southeast Asian Fisheries Development Center (SEAFDEC) for the Regular Collection of Segregated Wastes (Residuals Only) of SEAFDEC Facility;
