**Resolution No. 2020-075**

RESOLUTION CONFORMING AND APPROVING THE CY 2020 BARANGAY ANNUAL BUDGET AND 20% DEVELOPMENT FUND, 10% SK FUND, 5% BDRRMF AND GAD ATTRIBUTIONS OF BARANGAY DORONG-AN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on September 3, 2020 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the 2020 Annual Budget and 20% Development Fund, 10% SK Fund, 5% BDRRMF and GAD Attributions of Barangay Dorong-an, this municipality, to wit:

**Brgy. Dorong-an** CY 2020 General Annual Budget Involving an Appropriation of P3,262,000.50 and 20% Development Fund in the amount of 638,571.60, 10% SK Fund in the amount of P326,200.05, 5% BDRRMF in the amount of P163,100.03 and GAD Attribution in the amount of P462,128.58, approved by the Sangguniang Barangay on August 9, 2020 and was enacted thru Appropriation Ordinance No. 2020-01;

WHEREAS, the OIC-Municipal Budget Officer had reviewed in advance and endorsed to this August Body the said Barangay Annual Budget, 20% Development Plan, 10% SK Fund, 5% BDRRMF Plan and GAD Attribution which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budget, 20% Development Plan, 10% SK Fund, 5% BDRRMF Plan and GAD Attribution of Barangay Dorong-an likewise show apparent compliance with Section 287 of the Local Government Code, Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
