RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH IOILO SCIENCE AND TECHNOLOGY UNIVERSITY (ISAT-U) FOR THE DISTRIBUTION OF SOFT AND PRINTED COPIES OF INSTRUCTIONAL MATERIALS FOR STUDENT BENEFICIARIES IN THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the municipality in all its business transactions and sign in its behalf all contracts and obligations, and such other documents upon authority of the Sangguniang Bayan or pursuant to law or ordinance;

WHEREAS, ISAT-U is a public institution of higher learning, organized and existing under RA 10595 with Office Address at Burgos St., La Paz, Iloilo City, and with external campuses at Miag-ao, Barotac Nuevo, Dumangas and Leon;

WHEREAS, due to COVID-19 Pandemic, face-to-face classes in all educational levels is being discouraged, thus the need for online classes and/or distribution of instructional materials so as not to hamper the learning process of the students for this current school year;

WHEREAS, both the ISAT-U and LGU Tigbauan will coordinate with one another during the distribution of the instructional materials which shall be done every first Thursday of every month;

WHEREAS, ISAT-U shall provide in Tigbauan, a depository box for instructional materials with corresponding label to be placed in the municipal hall for the benefit of its students;


