RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH NEW LUCENA POLYTECHNIC COLLEGE (NLPC) FOR THE CONDUCT OF SHIELDED METAL ARC WELDING NC 1 AND NC II IN THE MUNICIPALITY OF TIGBAUAN.

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the municipality in all its business transactions and sign in its behalf all contracts and obligations, and such other documents upon authority of the Sangguniang Bayan or pursuant to law or ordinance;

WHEREAS, there are a number of unemployed out-of-school youths who signified their intention to undergo training on Shielded Metal Arc Welding (NC I and II) to gain technical and livelihood skills in this challenging time brought about by the COVID-19 pandemic;

WHEREAS, New Lucena Polytechnic College (NLPC) is a TESDA administered school duly registered and authorized to offer and conduct Shielded Metal Arc Welding (NC I and II) in the whole Province of Iloilo;

WHEREAS, the LGU of Tigbauan, Iloilo is a beneficiary for Training for Work Scholarship Program (TWSP) and to provide the venue for the conduct of Shielded Metal Arc Welding (NC I and II);
