RESOLUTION EARNESTLY REQUESTING POLICE GENERAL CAMILO PANCRATIUS CASCOLAN, CHIEF, PHILIPPINE NATIONAL POLICE, ONE (1) PATROL VEHICLE TO BE USED BY THE TIGBAUAN MUNICIPAL POLICE STATION OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, way back in 2015 the Philippine National Police had donated one unit of patrol vehicle for the Tigbauan Municipal Police Station of the Municipality of Tigbauan and by now, this is the only one (1) available patrol vehicle used by the PNP Police Station;

WHEREAS, because of the growing population of the Municipality of Tigbauan which is composed of 52 barangays and with a present total population of 68,373 inhabitants, more or less as of 2019 (actual survey), said patrol vehicle could not satisfy and/or respond to cases of emergencies, especially on criminal activities, this municipality;

WHEREAS, there is an immediate and dire need for an additional unit of patrol vehicle in order for the PNP to effectively serve our populace;

WHEREAS, due to budgetary constraints, the LGU-Tigbauan could not afford to purchase the needed additional patrol vehicle unless it can have other sources of funds;


NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, Chairman, Committee on Peace & Order and Public Safety and duly seconded by Hon. Dennis, T. Valencia, Hon. Marlon R. Teruñez, Hon. RESOLVED, to earnestly request Police General Camilo Pancratius Cascolan, Chief, Philippine National Police, One (1) Patrol Vehicle to be used by the Tigbauan Municipal Police Station of the Municipality of Tigbauan, Province of Iloilo;
