**Resolution No. 2020-086**

RESOLUTION CONFORMING AND APPROVING THE CY 2020 SUPPLEMENTAL BUDGET OF BARANGAY CORDOVA NORTE OF THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on October 12, 2020 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2020 Supplemental Budget of Barangay Cordova Norte, to wit:

*The appropriation of **Brgy. Cordova Norte** for the Supplemental Budget No. 2020-01 embodying Appropriation Ordinance No. 2020-01 in the amount of **P80,000.00** (MOOE is for the R/M Building and other Structure, R/M Office Equipment, R/M Transportation Equipment, other MOOE and Office Supplies) chargeable against MOOE-Socio Cultural-Savings/Surplus of the aforementioned barangay.*

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the said CY 2020 Barangay Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;
