**Resolution No. 2020 – 088**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH PHILIPPINE RED CROSS (PRC) TO AVAIL THE MEMBERSHIP ACCIDENTAL ASSISTANCE BENEFITS (MAAB) PROGRAM FOR ALL REGISTERED BARANGAY TANODS IN THE MUNICIPALITY OF TIGBAUAN

**WHEREAS**, Philippine Red Cross is a recognized voluntary, independent and autonomous non-governmental organization auxiliary to the authorities of the Republic of the Philippines in the humanitarian field, to assist said authorities in discharging obligations set forth in the Geneva Convention and the Statutes of the International Red Cross and Red Crescent Movement;

**WHEREAS**, Philippine Red Cross provides trainings on Disaster Risk Reduction Management (DRRM), First Aid, Search and Rescue, Disaster Preparedness among others and responds to incidents and calamities when circumstances warrants;

**WHEREAS**, Philippine Red Cross, thru Prudential Guarantee Accidental Insurance, provide its members, accident insurance;

**WHEREAS**, in consideration of the foregoing, the Municipality of Tigbauan realizes the need to accord it's personnel including Barangay Tanods, Municipal Disaster Risk Reduction Management (MDRRM) Personnel and Citizens Crime Watch (CCW) Members of said membership;

**WHEREAS**, the Municipality of Tigbauan, agrees to avail of PRC's Membership Accidental Assistance Benefits (MAAB) program for its member not covered by the said Special Laws, subject to the following terms and conditions;

• **UNDERTAKING OF THE PARTIES**

1. That the **PHILIPPINE RED CROSS (PRC)** shall:

- 1.1 be responsible for briefing the Municipality of Tigbauan Officer and Board Members on the Premiums and Coverage as part of the Municipality of Tigbauan, Red Cross membership program.

- 1.2 that the Municipality of Tigbauan members including their qualified dependents may avail of the services of Western Visayas Regional Blood Center in accordance with the blood assurance program.
- 1.3 provide Red Cross Membership Cards to all qualified members through the Officer of the Municipality of Tigbauan;
- 1.4 provide relevant instructions and training to all Municipality of Tigbauan members, consistent with its policies, rules and regulations as Automatic members of the 143 Red Cross Program to be scheduled within the membership period;
- 1.5 provide benefits and services under its Membership Accident Insurance (MAAB) to Municipality of Tigbauan members in accordance with the terms and conditions of a PRC accredited insurance provider.

2. That the **MUNICIPALITY OF TIGBAUAN** shall:

- a. Submit to Philippine Red Cross Iloilo Chapter all requirements of qualified members for enrollment in the program and issuance of ID's.
- b. Inform Philippine Red Cross of any accidents or death or any loss of ID card of any of the Municipality of Tigbauan members during the period of coverage and file claims within a period of thirty (30) days from the date of accident/ death/ loss of card at the PRC Iloilo Chapter.
- c. In recognition of Philippine Red Cross Iloilo's obligation to provide blood (stated in 1.2), the LGU shall undertake to conduct with PRC, quarterly blood drives in order to guaranty the availability of blood for the municipality.
- d. Update Philippine Red Cross on the status of incidents in the locality so as to apprise PRC Iloilo of the actual situation on the ground.


NOW, THEREFORE, on motion of HON. JERRY T.TUARES, *Chairman, Committee on Barangay Affairs (jointly with the Committee on Women, Family, Social Services & Senior Citizens (Including Indigents), chaired by Hon. Suzette Marie Hilado-Banno)* and duly seconded by Hon. Dennis T. Valencia, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Reynaldo E. Tumabotabo and Hon. Norberto T. Turalba;

RESOLVE, AS IT IS HEREBY RESOLVED, to authorize The Municipal Mayor, Atty. Suzette T. Alquisada, For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement (MOA) With Philippine Red Cross (PRC) To Avail The Membership Accidental Assistance Benefits (MAAB) Program For All Registered Barangay Tanods In The Municipality Of Tigbauan.

RESOLVED FURTHER, to forward copies of this Resolution to the Office of the Municipal Mayor, Atty. Suzette T. Alquisada, to the Philippine Red Cross and to all concerned for their information and/or appropriate action.
