**Resolution No. 2020-089**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRAANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO PROVINCIAL GOVERNMENT FOR THE ESTABLISHMENT/PURCHASE OF AN ULTRA HIGH THERMAL DECOMPOSITION SYSTEM/PYROLYSIS FOR THE MUNICIPALITY OF TIGBAUAN.

**WHEREAS**, Republic Act No 9003 (R.A. 9003) otherwise known as the “Ecological Solid Waste Management Act of 2000” was passed into a law on January 26, 2001 and mandates local government units to implement the same;

**WHEREAS**, the Province of Iloilo, in compliance with RA 9003 has adopted the “Ecological Solid Waste Management Program” to promote proper solid waste management in the whole Province and ultimately help in eradicating problems caused by garbage;

**WHEREAS**, the DENR issued Administrative Order No. 2001-34 (*Implementing Rules and Regulations of RA 9003*) and Administrative Order No. 2006-10 to set the Guidelines on Closure and Rehabilitation of Disposal Facility and Guidelines on Categorized Sanitary Landfill respectively;

**WHEREAS**, the Province of Iloilo has strategized the clustering of municipalities for use of common Sanitary Landfill as an immediate solution for the need of municipal LGUs for a final disposal facility and to be compliant with the requirement of law;

**WHEREAS**, the Iloilo Provincial Government has appropriated the amount of **Thirty Million Pesos (P30,000,000.00)** for the establishment of clustered common Sanitary Landfill or for the purchase of solid waste support facilities for various municipalities;

**WHEREAS**, the Municipality of Tigbauan is one of the local government units identified as recipient of the project and willing to assist/accommodate nearby municipalities;

**WHEREAS**, the amount of **Fifteen Million Pesos (P15,000,000.00)** shall be transferred to the Municipality of Tigbauan for the purpose thereof;

**WHEREAS**, in consideration of the foregoing premises, the parties hereby agree to jointly work and cooperate effectively in the operation of an Ultra-High Thermal Decomposition System/Pyrolysis with the following responsibilities:

**A. The Iloilo Provincial Government shall:**

1. Provide Financial Assistance/Donation in the amount of **Fifteen Million Pesos (P15,000,000.00)** for the establishment of an Ultra High Thermal Decomposition System/Pyrolysis);
2. Provide technical and other forms of assistance for the successful utilization of the facility;
3. Conduct Information, Education Campaign (IEC) and training for a sustainable management and maintenance of the facility;
4. Conduct regular monitoring and evaluation of the operation and management of the facility for appropriate reporting and to make sure that the facility work is in progress.

**B. The Municipality of Tigbauan shall:**

1. Issue official receipt evidencing the receipt of the fund transferred/granted;
2. Initiate procurement process within six (6) months from receipt of fund transferred/granted;
3. In case of non-implementation of the project, shall return/refund the whole amount within six (6) months from release of the said fund transferred/granted;
4. Submit liquidation report with complete documents within three (3) months from purchase of goods;
5. Submit Resolution of the Sanggunian authorizing the Municipal Mayor to sign the Memorandum of Agreement (MOA);
6. If the result of liquidation is in excess of the amount transferred, the unused amount shall be returned to the FIRST PARTY upon liquidation;
7. Provide support funds for a sustainable management and operation of the Facility;
8. Conduct regular inspection and submit progress and development reports of the facility operation and any problem which may arise; and
9. Provide a permanent manpower component for the full operation and management of the facility.


NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation* and duly seconded by Hon. Dennis T. Valencia, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez,

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan to Enter Into A Memorandum of Agreement (MOA) With the Iloilo Provincial Government for the Establishment/Purchase of an Ultra High Thermal Decomposition System/Pyrolysis for the Municipality of Tigbauan;

RESOLVED FURTHER, to furnish copies of this Resolution to the Iloilo Provincial Government thru Governor Arthur R. Defensor, Jr., to the Office of the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada and to all concerned for their information and/or appropriate action.
