RESOLUTION ENDORSING THE PROGRAMS AND/OR PROJECTS FOR THE RELEASE AND UTILIZATION OF THE LOCAL GOVERNMENT SUPPORT FUND-COVID 19 FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS IN THE "BAYANIHAN TO RECOVER AS ONE ACT"

**WHEREAS**, on September 11, 2020, President Rodrigo Duterte signed into law the "Bayanihan to Recover as One Act (Bayanihan 2)", the government's second coronavirus pandemic relief measure meant, to address the country's health and economic problems stemming from the COVID-19 outbreak;

**WHEREAS**, Local Budget Circular No. 128 issued on September 17, 2020 set the Guidelines on the Release and Utilization of the Local Government Support Fund - COVID-19 Financial Assistance To Local Government Units in the Bayanihan to Recover as One Act, Republic Act No. 11494;

**WHEREAS**, said Local Budget Circular requires that the appropriated amount for the LGSF-COVID-19 FA to LGUs under the "Bayanihan to Recover As One Act" shall be exclusively used for financial assistance to LGUs to support the COVID-19-related programs, projects and activities (PPAs) and expenses;

**WHEREAS**, the Sangguniang Bayan - Tigbauan, Iloilo endorses the following programs and projects, as allowed under LBC No. 128, to wit:

1. Procurement of kits for COVID-19 testing in the amount of P500,000.00;
2. Repair and maintenance of ambulance, medical transport vehicle and emergency response vehicle in the amount of P500,000.00;
3. Food assistance and other relief goods for affected households in the amount of P2,000,000.00; and
4. Expenses for the repair of Quarantine Facilities and construction of additional building to accommodate COVID-19 patients and persons under monitoring/investigation in the amount of P3,000,000.00.

**WHEREAS**, the Local Government Unit of Tigbauan, Iloilo is in need of the total amount of Six Million (P6,000,000.00) as Financial Assistance to implement programs and projects in Republic Act No. 11494 or the Bayanihan to Recover as One Act;
