RESOLUTION DECLARING THE 22ND ADLAW SANG TIGBAUAN AS MUNICIPAL WORKING HOLIDAY AND TEMPORARILY TRANSFERRING THE DATE OF THE CELEBRATION FROM FOURTH FRIDAY OF OCTOBER, AS PER TOURISM CODE OF THE MUNICIPALITY OF TIGBAUAN, TO LAST FRIDAY OF OCTOBER, SPECIFICALLY, OCTOBER 30, 2020"

WHEREAS, Adlaw sang Tigbauan is a celebration in the concept of history as it is believed that it was the day when the Bornean Settlers in Siwaran in search for a greener pasture followed the rays of the golden sun and came to the place called Katigbawan, during the time of harvest season;

WHEREAS, as history did not specify the month of October as the date the Bornean Settlers arrived in Tigbauan, the people of Tigbauan believed that said harvest season is October, thus the celebration;

WHEREAS, it is provided in the Tourism Code of the Municipality of Tigbauan that Adlaw sang Tigbauan shall be celebrated every FOURTH FRIDAY OF OCTOBER EACH YEAR;

WHEREAS, because of the COVID-19 pandemic, the celebration cannot be held as it is in ordinary times;

WHEREAS, due to the many limitations in the holding of holidays and festival brought about by the pandemic, it was agreed by the different sectors to transfer the celebration of 22nd Adlaw sang Tigbauan from the 4th Friday of October to the last Friday of October for this year 2020;
