RESOLUTION CONFORMING AND APPROVING MDC EXE. COM RESOLUTION FOR THE PRIORITIZATION AND APPROVAL OF VARIOUS MUNICIPAL AND BARANGAY DEVELOPMENT PROJECTS INCLUDED IN THE 20% IRA FUND CY 2020 IN THE AMOUNT OF SEVEN MILLION ONE HUNDRED THIRTY THOUSAND PESOS (P7,130,000.00) OF THE MUNICIPALITY OF TIGBAUAN AND FOR THE IMMEDIATE IMPLEMENTATION THEREOF

WHEREAS, Sangguniang Bayan Tigbauan has conformed and approved Annual Investment Program (AIP) CY 2020 in June 2019 which indicated the approved allocation for 20% Internal Revenue Allotment (IRA) Fund CY 2020 in the amount of Thirty Three Million Seventy-Two Thousand Seven Hundred Twenty-Six Pesos and Seventy-Two Centavos (P33,072,726.72);

WHEREAS, allocations in the different programs, projects and activities under items **Municipal Rural Development Program, Barangay Rural Development Program, Improvement of Day Care Centers, Municipal Environmental and Natural Resources Development Program, and Tourism Development Program** have been made in lump sum, thus the need for prioritization;

WHEREAS, after thorough discussion with the members of the Municipal Development Council - Executive Committee (MDC-EXECOM) it was unanimously approved that the following identified Programs/Projects/Activities are prioritized for implementation:
